

## **OXFORD STRIDE LIABILITY WAIVER**

## RELEASE, WAIVER AND INDEMNITY

## READ CAREFULLY BEFORE SIGNING:

In consideration of the acceptance to participate in the **Oxford Run Club** which Oxford Run Club will be held once a week for a twelve week period commencing January 16, 2019 convening at 1021 West Hastings Street, Vancouver and which activities shall include all activities, events or services provided, arranged, organized, sponsored or authorized by the Vancouver Running Company Inc. and the Releasees (as defined below) and shall include, but not limited to, running events, orientational and instructional courses, seminars and sessions, travel, transport and accommodations and other activities and services in any way connected with or related to the Oxford Run Club (the "**Events**"):

- 1. I acknowledge that I am aware of the risks to my person and to my property by accident, injury, illness, loss, damage, death or otherwise as a result of participating in and attending at the Events and agree that I am participating in and attending at the Events voluntarily at my own risk.
- 2.
